The <b>annual</b> tuition is based on the <u>Beachwood Nursery School's Calendar of 180 days</u> for a 5-day program, 105 days for a 3-day MWF program, and 75 days for a 2-day T/Th program. Tuition is an annual tuition which may be paid in full or in 10 equal payments beginning August 1 <sup>st</sup> for the month of September and ending May 1 <sup>st</sup> for the month of June. Tuition for each month is due in advance of that month. <b>However</b> , tuition received after the 15 <sup>th</sup> of the current month of attendance will incur a <b>\$25.00 late payment fee</b> . If payment is not received by the 30 <sup>th</sup> of the current month of attendance, your child may not continue attending school until payment for <b>two consecutive</b> months is received. Habitual lateness in payments will be cause to dis-enroll your child from BNS. (A return check charge is \$30.00)

2. School Closure	
If we are mandated by the State of NJ, the Dept of Children & Families, the Office of Licensing, and/or the Dept. of Health to close our school due to a public health emergency for a period of less than 2 calendar weeks, there will be no tuition refund. This allows us to pay our dedicated staff and maintain our school so we can quickly reopen. Our goal is to remain open to serve the families that need child care during this co-vid crisis. If a case of Co-vid 19 should occur in a classroom, only that classroom will be required to follow the procedure the Ocean County Health Department recommends.	
3. Personal Guarantee – Agreement to Pay – Parent-School Tuition Policy 2020-2021 – Beachwood Nursery School
